R.M. OF SPRINGFIELD Solid Waste Management Program Review



The Rural Municipality of Springfield is planning on changing the funding structure of its residential solid waste management program. At the present time, curbside waste pickup and the use of transfer stations are services that are funded by the R.M. 's general tax base.

Although the tax that residents contribute to this service is equalized, the actual solid waste management services that residents receive is not equal. Currently, curbside pickup is only provided to a portion of the R.M. and residents who produce more waste are being subsidized by residents who produce less waste and recycle more.


The R.M. is exploring a change to the existing funding model for curbside pickup and the use of transfer stations in order to provide a more equitable solid waste management service to its residents. At the same time, the R.M. is encouraging the reduction of garbage that is produced, resulting in more local recycling.

The R.M. is in the initial phase of this project, and is looking to work with residents to provide information on the concept and gather feedback.

We will be hosting a series of Workshop events between September 23 and October 2, 2019. You are invited to attend any one of the five Workshops to learn more about this project and share your thoughts. Workshop dates and information can be found on our website, www.rmofspringfield.ca.

Canada Post Update

Recently Canada Post embarked on a project to change addresses across the RM of Springfield. The official changeover took place on August 19, 2019. Council heard requests from residents to change the name of their postal address. If an effort to address these concerns Council met with Canada Post and was told that creating an alternate address was possible. On the September 2, 2019Council meeting a



resolution was passed with 2 further options. All residents can now choose between there current area (ie: Anola, Oakbank Sunnyside etc.) or Springfield. Please note that your Postal Code DOES NOT change. Additionally, in the designated area of Cooks Creek, residents can chose between Cooks Creek, Hazelridge or Springfield. Again, the Postal Code DOES NOT change, but residents can use the name that they prefer. Please see the example below. If you have nay further questions or require clarification, please contact your local postal outlet.

Example: 100 Springfield Center Drive, Oakbank, MB ROE 1J0 or 100 Springfield Center Drive, Springfield, MB ROE 1J0.

2019 Property Tax Information

2019 Property Taxes are due by 4:30 p.m. on Thursday, October 31, 2019

2019 Property Tax Bills were mailed out in July. If you have not received your bill please contact the Municipal Office to ensure we have your correct mailing address.

To avoid line ups leading up to tax due date, several payment options are available as follows:

<u>Pay by Phone / Internet:</u> Most financial institutions offer pay-by-phone services or on-line banking. Use your property tax roll number for bill payment. (enter all 10 digits except the decimal point) Please allow 2-3 business days to process.

<u>Pay by Mail:</u> Insert your payment (cheque or money order), drawn in favour of the "R.M. of Springfield", add postage and mail to Box 219, Oakbank, Manitoba R0E 1J0. Please make reference to your property tax roll number. Mail must be post marked on or before October 31. Post dated cheques are accepted.

<u>24 Hour Drop Off:</u> Drop your payment in the mail slot located at the front entrance of the Municipal Office, 100 Springfield Centre Drive, Oakbank.

Pay in Person: Bring your bill payment to the Municipal Office between the hours of 8:30 a.m. and 4:30 p.m., Monday to Friday. Payment options include cheque, cash and Interac.

Please note: Credit Cards are not accepted for property tax payments.
